

Delhi cop suspended for kidnapping minors, extortion

Delhi police Sub-Inspector (SI) posted at the Sarai Rohilla Police Station has been suspended after serious allegations emerged against him for illegally detaining six minor boys and demanding money from their parents in exchange for their release.

"The Sub-Inspector has been suspended. A departmental inquiry is underway to investi-

gate his conduct. A vigilance probe has also been ordered," said Raja Banthia, District Commissioner of Police (DCP) North. The incident took place on Wednesday night when SI Balbir Chand received a PCR

call at about 11 pm regarding a scuffle involving minors near the Sarai Rohilla area. According to the call, two juveniles had been beaten up by six other boys while returning from a coaching centre. All of them reportedly belonged to Bhopura, a locality in Ghaziabad,

When parents refused to give in to demands, **SI Balbir reportedly** abandoned the boys on

> the roadside the next morning and returned Uttar Pradesh. Following the call, SI Balbir reached the spot and took all eight minors — two victims and six accused — to the police station for inquiry. It was later revealed that the six accused

boys were on their way to the to be released. Sarai Rohilla Railway Station to catch a train to the Khatu Shyam Temple in Rajasthan. All the boys were between 15 and 17 years of age.

At the police station, the two injured boys were sent for medical examination and their parents were also contacted. The parents of the six accused were son. In a conversation with Newsweek magazine in New York, Jaishankar gave a detailed account of the tense negotiations leading up to the ceasefire after India launched Operation Sindoor in retaliation for the April 22 terror attack in Pahalgam in Jammu and Kashmir. Calling the attack an "act of economic warfare," he said it was designed to destroy Kashmir's tourism industry and provoke communal tensions.

n a first, the Supreme Court has introduced a formal reservation policy for the direct appointment and promotion of its staffers belonging to scheduled castes and scheduled tribes. The decision was communicated in a circular issued on June 24 to all Supreme Court employees.

As per the directions of the Competent Authority, it is to notify for the information of all concerned that the Model Reservation Roster and Register has been uploaded on the Supnet (internal email network) and it is made effective from June 23, 2025.

"It is to inform further that in case of objections/representations raised by any staff member about mistakes or inaccuracies in the roster or register, they may inform about the same to the Registrar (Recruitment)," the circular said.

As per the circular and the model roster now in effect, top court employees will receive a 15 per cent quota and ST employees a 7.5 per cent quota in promotions. According to the policy, the quota benefits will be available to registrars, senior personal assistants, assistant librarians, junior court assistants and chamber attendants.

The war of words between billionaire Elon Musk and President Donald Trump over the big bill of tax breaks and spending cuts is heating up again, with Musk claiming he may form a new political party and Trump blasting the Tesla CEO over electric vehicle subsidies.

The most prominent divide in the relationship between Musk and Trump is the president's big bill. Musk ramped up his criticism of the bill just three days ago, arguing the legislation that Republican senators are scrambling to pass would kill jobs and bog down burgeoning industries.

Musk, who is also CEO of SpaceX, posted on X on Saturday that the bill would be "political suicide for the Republican Party".

Report on AI crash soon

rearly 20 days after the Air India crash in Ahmedabad killed 270 people including 241 on board, Aircraft Accident Investigation Bureau (AAIB) is likely to release a preliminary probe report by next week.

The document, which is likelv to be four to five pages long, will be crucial because it will provide initial insights into the crash on June 12, including the possible causes, sources said here on Tuesday.

As per International Civil Aviation Organisation (ICAO) guidelines, India is required to file a preliminary report within 30 days of the crash. The complete probe report is expected in roughly two months from now, which would be three months from



the day of the crash. Sources said the preliminary report will include details about the aircraft, which was a Boeing Dreamliner 787-8, the crew, conditions at the Ahmedabad airport, and the weather on June 12, when Air India flight 171 crashed, roughly 30 seconds after taking off.

Details about the wreckage will also be part of the report, as will the name of the inves-

tigator in charge. The document will chart the progress of the probe, outline the next steps that need to be taken and highlight areas that need further investigation.

Just days ago, the junior minister for civil aviation, Murlidhar Mohol had said all angles are being investigated in the crash, including sabotage.

Cochlear implant surgery performed successfully

Digital India bridges divide, becomes people's movement: PM

Minister rime Narendra Modi asserted on Tuesday that the Digital India initiative launched a decade ago bridged the digital divide between haves and have-nots and democratised opportunity, stressing that it has become a people's movement.

In a social media post, he said while decades were spent doubting the ability of Indians to use technology, his Government changed this approach and trusted the ability of citizens to use technology.

Modi asserted that his Government used technology to eliminate the gap between the haves and the have-nots, he added. "When the intent is right, innovation empowers the less empowered. BJP slams Tejashwi Yadav over Waqf act remarks

Congress slams 10 years of Digital India as lofty claims

ith the Modi Government hailing Digital India as a people's movement that democratised technology in 10 years, the Congress on Tuesday claimed the fine print of its "lofty claims" is marred by unfulfilled promises, digital exclusion of the marginalised, hurting privacy and weakening transparency.

Digital India is a flagship programme of the Government launched on July 1, 2015, by Prime Minister Narendra Modi with the vision to transform India into a digitally empowered society and knowledge economy.

Questioning the Government's claims of the success of the initiative that completed 10 years, Congress president Mallikarjun Kharge cited data like villages and schools that are yet to get broadband connectivity, the

rising debt of state-owned telecom companies MTNL and BSNL and a surge in cyber crimes.

At the same time, the opposition party sought to take credit for laying the foundation of several pathbreaking initiatives like Aadhaar and UPI during its rule.

'The fine print of Modi Govt's lofty claims of 'Digital India' is marred by unfulfilled promises and false claims," Kharge said in a social media post...as of 26th June 2025, under the BharatNet project, a total of 6.55 lakh villages were supposed to be targeted for broadband connectivity, but out of these, 4.53 lakh villages, ie 65 per cent of them are yet to be covered, he claimed.

"The project's deadline has been revised at least 8 times in 11 years. A meagre 0.73 per cent (766) Gram Panchayats currently have active Wi-Fi services. When the private players are opting for 5G, BSNL has not yet completed its tar-



said.

Even after receiving three revival packages worth over ₹3 lakh crore — ₹69,000 crore in 2019, ₹1.64 lakh crore in 2022, and ₹89,047 crore in 2023 — it still lags behind private players, Kharge said.

He pointed out that BSNL's debt rose by 291.7 per cent, from ₹5,948 crore in March 2014 to ₹23,297 crore in March 2024

"MTNL's debt increased by 136.2 per cent, from ₹14,210 crore to ₹33,568 crore over the

Kharge also flagged the issue of "digital exclusion of the marginalised".

He said 75.3 per cent of people aged 15 and above in the country do not know how to use a computer.

"This includes 81.9 per cent in rural areas and 60.4 per cent in urban areas, highlighting a significant digital skills gap. (NSS survey, 2020-21)," he

said. Nearly 7 crore registered workers were excluded from MNREGA by imposing the condition of AADHAAR-based payment, he said.

Kharge further claimed that 54 per cent of Government schools do not have an internet connection, 79 per cent have no desktop computer, 85 per cent lack a projector and 79 per cent do not have a smart classroom.

He also alleged that it has hurt privacy and weakened transparency.

"None less than PM Modi himself, reportedly told Ministers and Secretaries that India saw over 10 crore cyberattacks since the Pahalgam terror attack. Cybersecurity incidents rose by about 76.25 percent from 2020 to 2024. These cases increased from 11.58 lakh in 2020 to over 20.41 lakh in 2024," Kharge claimed, cit-

ing CERT-In data. Between 2022 and 2024, digital arrest scams and related cybercrimes in India nearly tripled, and the money lost rose

21 times, he said, citing replies to questions in the Raiva Sabha. TheI Act brought by the Congress party is being weakened by bringing a flawed Data Protection Law, he alleged.

"We were told that demonetisation will reduce cash transactions, but cash in circulation has risen, even in the last year," Kharge said.

"Narendra Modi ji, we need to place on record that it was under the then PM Dr Manmohan Singh, that we created the Direct Benefits through AADHAAR and UPI architecture, which has made India a leader in Digital transactions.

"National Payments Corporation of India (NPCI) which runs UPI transactions, was established by the UPA Government in 2009 itself," he said. First Direct Benefit Transfer Scheme — PaHaL for LPG subsidy to 9.55 crore beneficiaries was launched by Congress-UPA in June 2013, Kharge pointed out.

Is a new alternative to SAARC in the making?

As the idea of an alternative to SAARC gains momentum, India must act now to safeguard its regional power status

hina has long desired to have a foothold in South Asia, the region which is strategically and economically conducive for its aspirations. Now it has got an opportunity to make an entry by forming a group of South Asian countries on the lines of SAARC. A recent trilateral meeting between China, Pakistan, and Bangladesh in Kunming has reignited discussions about the future of regional cooperation in South Asia. Reportedly these three countries are exploring the formation of a new

regional organisation, potentially positioning it as an alternative to the longstalled South Asian Association for Regional Cooperation (SAARC).

While Bangladesh has officially downplayed the political implications of the Kunming meeting, the timing and context suggest a more ambitious agenda. Formed in 1985, SAARC includes eight South Asian nations: Afghanistan, Bangladesh, Bhutan, India, the Maldives, Nepal, Pakistan, and Sri Lanka. However, the organisation has been largely dysfunctional for the past decade

The last SAARC Summit was held in Kathmandu in 2014. Since then, India-Pakistan tensions and broader geopolitical realignments have kept SAARC in cold storage, leaving a vacuum in regional diplomacy. China has steadily increased its footprint in South Asia through its Belt and Road Initiative (BRI), infrastructure

investments, and strategic partnerships. Its closer alignment with Pakistan, formalised through the China-Pakistan Economic Corridor (CPEC), offers both countries an incentive to shape a new multilateral platform that bypasses India's dominance. For Pakistan, a new grouping-especially one that includes China-could allow Islamabad to regain some diplomatic leverage in the region.

However, the formation would not be a cakewalk. Bangladesh's official dismissal

of alliance-building reflects its delicate balancing act. While Dhaka has strong economic ties with China and shares historical ties with Pakistan, its political, cultural, and economic proximity to India cannot be ignored.

Moreover, Bangladesh's reluctance to appear part of any China-Pakistan axis suggests that it values its autonomy and strategic balance. For India, the proposed bloc can a direct challenge to its regional dominant power. The creation of a parallel regional order where China, an external power, sets the agenda in South Asia could erode India's dominance.

If countries like Sri Lanka, Nepal, and the Maldives sign on - drawn by investment promises - India may find itself increasingly isolated in its immediate neighbourhood. However, India also has considerable soft power, historical linkages, and economic influence in the region. The backlash against China's debt-trap diplomacy and increasing concerns over sovereignty could deter many nations.

The need of the hour is that India must take proactive steps to revive SAARC by engaging bilaterally with member states. India must intensify economic and infrastructure partnerships with Bangladesh, Sri Lanka, Nepal, and the Maldives. India is better suited to lead South Asia than China because of its historical and geographic advantages which are deeply rooted in its South Asian identity, While SAARC may be comatose, the need for regional cooperation is more urgent than ever. India must seize the moment to reassert its role as a natural leader in South Asia-not through coercion.



AAP's byelection wins spark political revival

Once seen as a Delhi-centric outfit, AAP's latest wins in BJP strongholds Ludhiana West and Visavadar signal not only a shift in public sentiment but also the party's growing national stature

he Aam Aadmi Party is delighted after its recent win in the Gujarat and Punjab by-elections. These victories in states dominated by the BJP indicate a shift in the Party's fortunes. The AAP, once viewed as a Delhi-centric party ruling only in Delhi, has expanded over the years, gaining a national character. It now governs Punjab and is beginning to make inroads in states like Gujarat. which has long been considered a stronghold of the BJP.

The AAP was founded by Arvind Kejriwal in 2012, following his departure from Anna Hazare's anti-corruption movement, which claimed to transform Indian politics. Leading a successful movement, Kejriwal first became the Chief Minister of Delhi in 2013.

He was sworn in as the Chief Minister of Delhi for the second time on February 14, 2015. He first assumed office on December 28, 2013, becoming the youngest Chief Minister of Delhi. The AAP ruled Delhi from 2015 until 2025.

The by-election victory is vital for Kejriwal after his Party's loss in February's Delhi Assembly poll. Atishi, the former chief minister, stated, "The victories in Ludhiana West and Visavadar show that people want effective governance. Underestimating Arvind Kejriwal's approach is a mistake — he plans to imple-ment his model nationwide. Congratulations to the people of Ludhiana and Visavadar, and best wishes to AAP workers in Punjab and Gujarat."

The Aam Aadmi Party (AAP) retained the Ludhiana West assembly seat in Punjab, with Sanjeev Arora defeating Congress's Bharat Bhushan Ashu by 10,637 votes.

In Gujarat's Junagadh district, Gopal Italia won against BJP's Kirit Patel in Visavadar by 17,554 votes. AAP has now achieved victories in both seats with double the margins compared to the 2022 elections. These victories have provided hope for the Party's leaders, workers, and supporters. Although winning or losing is part of electoral politics, what truly matters is a party's ability to recover and thrive.

With the approaching Assembly polls scheduled for 2027, AAP's double victory indicates a clear indication that AAP is not out. Only in February did the AAP face a setback in the Delhi Assembly polls, resulting in the end of its ten-year rule, with the BJP winning 48 out of 70 seats.

It was a bitter loss for the Aam Aadmi Party (AAP), as it not only failed to return to power in Delhi but also saw many of its top leaders, including Kejriwal, defeated by the BJP. There were other reasons for the loss. It includes the disenchantment of the middle classes over the AAP and its leaders. AAP's welfare schemes mainly

benefit lower-income groups while neglecting the salaried middle class. Slum dwellers, migrant workers, and daily-wage labourers — AAP's loyal voter base — receive subsidies and cash transfers, leaving those in the middle-income group feeling overlooked.

Once a hero to the middle class and marginalised, Kejriwal's aura has faded. Yet, the uncanny politician cannot be written off after the by-election win.

The Aam Aadmi Party (AAP) is part of the Opposition coalition INDIA and worked with Congress in the 2024 elections. However, both parties have realised that this partnership has not helped either.

After the by-election win, Kejriwal has declared that now the AAP is considering running independently in the upcoming elections. This decision, along with the AAP's stronger presence in the opposition following its recent by-election wins, makes the Party's future in Indian politics quite interesting.

India's rising score but falling rank in gender equality

Is India truly progressing towards gender equality, or are its gains being undermined by persistent gaps in key areas, especially political representation? As metrics in education, health, and economic participation show incremental advances, a sharp decline in political empowerment casts a shadow over development

ccording to the World Economic Forum's 2025 Global Gender Gap Report, India poses a conundrum. The global rating of India has fallen from 129 to 131 out of 148 international locations, no matter its gain in its overall gender parity rating, which went from 64.1 per cent to 64.4 per cent.

The quantity and sustainability of the improvements made are known as a query by means of this improvement. Is India making progress toward gender equality, or is this improvement being overshadowed by other areas in which development has been relatively gradual?

The Metrics Behind the Movement

The Global Gender Gap Index evaluates gender parity in four different areas: political empowerment, health and survival, educational attainment, and economic involvement and opportunities. India's score in three of these categories has remained stable or improved. However, the total performance has been significantly impacted by the loss of political empowerment.

India's score in 3 of these categories has remained solid or progressed. However, the entire overall performance has been appreciably impacted by the loss of political empowerment.

India has made quantifiable strides in a number of regions, along with monetary participation and possibility. One of the number one factors of the 0.9 per cent factor increase on this subindex's rating is the development in parity in predicted earned income, which accelerated from 28.6 per cent to 29.9 per cent.

This minor upward thrust is massive given the ancient gender-based economic disparity in India. Women endured to take part in the labour pressure on the best price in India's history, at 45.9 per cent. Regardless of this stability, the commerenterprise keeps facing problems which include informality, wage inequality, and a lack of social guarantees.

Some other regions of development indicated instructional attainment. India's rating extended to 97.1 per cent, reflect-

ing nearly frequent literacy parity and better female tertiary schooling attendance. Secondarylevel enrolment figures have come to be further encouraging, and ladies' gross enrolment now marginally surpasses boys'. Even though there's nevertheless a giant gap between educational attainment and professional potentialities.

India's parity score in Health and Survival has improved as a result of longer healthy life expectancy and a better birth — sex ratio. Maternal health initiatives and increased access to healthcare programs like Ayushman Bharat have contributed to a more than 50 per cent decrease in maternal mortality over the past ten years. The overall ranking has dropped due to a sharp reduction in the Political



Empowerment dimension, despite improvements in economic, health, and education metrics. The proportion of women in cabinet positions fell from 6.5 per cent to 5.6 per cent, while their representation in Parliament fell from 14.7 per cent to 13.8 per cent. These decreases are part of a longer-term downward trend that began in 2023. Given that the Women's Reservation Act of 2023 calls for a one-third reservation for women in state assemblies and parliament, this is especially

disheartening. However, this law won't take effect until after the general elections in 2029 due to continuing procedures like the national census and delimitation. In the meanwhile, few political parties have taken explicit steps to increase female representation, and they are not constitutionally compelled to do so. In India, women have long fought for political epresentation.

The Women's Reservation Bill was passed after various parliamentary hurdles and more than thirty years. This delay further solidifies the long-standing opposition to female leadership in Indian Governmental institutions and demonstrates a lack of political will.

South Asia and Beyond

When compared to its South Asian neighbours and the BRICS countries, India's relative decline becomes even more apparent. Stronger political representation and more successful grassroots empowerment initiatives are the main reasons why nations like Bangladesh and Nepal have outperformed India in gender parity rankings. India's performance appears particularly low when viewed from this regional perspective, underscoring the urgent need for policy reform.

Furthermore, India still does poorly on measures like the employment - education divide, which should ideally demonstrate greater synergy.

Women make up less than 20 per cent of the workforce and contribute a small portion of the GDP, despite high rates of reading and graduation. Oxfam India 2020 research found that women's unpaid labour contributes around ₹19 lakh crore to the economy annually, which traditional economic measurements do not account for.

Bridging the Gap

Even while India has made significant progress towards achieving gender parity in economic inclu-



Policy Gaps

The delayed implementation of the Women's Reservation Act, which was passed in 2023, is one of the most obvious gaps. It appears unlikely that the plan to reserve a third of seats in State Assemblies and Parliament would be carried out before 2029. In addition to representation, this delay affects the wider ramifications of having women in leadership roles, including the allocation of resources and t he formulation of policies.

Furthermore, even if women's labour market participation is at its highest point ever — 45.9 per cent - this number conceals a number of issues, including salary inequities, the quality of jobs, their prominence in the unorganised sector, and the absence of social protections. The majority of working women still have low-wage, precarious occupations with few opportunities for growth.

Similar to this, even if initiatives like Jan Dhan Yojana and MUDRA loans have improved financial inclusion, it is still surface. According to the World Bank's Findex Survey, one-third of all women's accounts remain dormant. Despite having bank accounts, women continue to struggle with financial independence and decision-making.

Social and Cultural Norms

Patriarchal conventions still limit women's freedom, independence, and involvement. Gender roles are embedded from a young age and influence financial decisions, career choices, and leadership ambitions. Early marriage is still common and daughters are still viewed as liabilities in many rural areas of India, which hinders progress in school and the workplace.

Women still experience the glass ceiling and glass cliff in metropolitan environments, where they are either excluded from leadership positions or assigned to unstable ones. According to a McKinsey analysis, reducing the gender employment gap might boost India's GDP by \$770 billion by 2025. However, this promise is still mostly unrealised.

Policy for Accelerated Progress

India needs to take a comprehensive, whole-of-society strategy in order to attain true gender parity. Implementing employment and skill development initiatives that provide women with digital and vocational training is a top priority, especially in high-growth industries like technology, clean energy, and logistics.

Gender-sensitive labour regulations should include provisions for flexible work schedules, workplace safety, and equitable remuneration. Increased political representation and mentorship initiatives are necessary to support women's leadership. With ministries and state Governments allocating funding according to gendered demands and outcomes, gender-responsive budgeting is crucial. Additionally important are reasonably priced child care and assistance for self-help groups via digital literacy and business training. Education changes should encourage girls to pursue STEM fields and emphasise gender sensitisation from an early age. Progress will be monitored and accountability will be enhanced by routine data gathering via a national gender dashboard. Investing in women is not just about equality; it is also a significant driver of inclusive development and economic success in India. Gender parity is crucial if India is to grow into a \$5 trillion economy and a major world power. According to the facts, families succeed, communities flourish, and the national GDP increases when women are economically empowered, educated, and healthy. The best strategy to guarantee long-term socioeconomic resilience is to invest in women.

How the Modi Government rewrote India's growth story after a lost decade

Why Kuruba tribe deserves schedule tribe status

office and one year into its third term, India finds itself at a vastly different juncture than it did in 2014. After a decade of drift, indecision, and policy paralysis under the UPA regime, the BJPled NDA, under Prime Minister Narendra Modi, has delivered a decisive shift in both vision and execution. The contrast between the two eras is not merely one of leadership style; it is a difference in outcomes, priorities, and national confidence. The UPA years, especially during its second term (2009–2014), were marred by scandals, economic slowdowns, and administrative inertia.

Despite India's potential, governance was often reduced to managing coalition compulsions and firefighting reputational damage. Flagship welfare programs lacked targeting, leakages were rampant, and large sections of the poor remained excluded. In stark contrast, the Modi Government embraced technology-backed delivery and scale.

Over 81 crore people today receive free food grains under the PM Garib Kalyan Anna Yojana, while the Swachh Bharat Abhiyan has led to the construction of over 12 crore toilets, transforming rural sanitation, an area long neglected during the UPA years. While the UPA Government often spoke extensively about inclusive growth, it failed to operationalise financial inclusion at the grassroots level.

The Modi Government made inclusion tangible through the Jan Dhan-Aadhaar-Mobile (JAM) trinity, revolutionising welfare delivery. Over 52 crore loans have been provided under the Mudra Yojana, with 68 lakh street vendors empowered through PM SVANidhi. Direct Benefit Transfers (DBT) to 20 crore women during the pandemic stand as a testament to real-time governance, a concept alien to the UPA era, which was defined by middlemen and red tape. In a major achievement over the past eleven years, the Direct Benefit Transfer system under Prime Minister Narendra Modi's Government has revolutionised welfare delivery in India, resulting in cumulative savings of ₹3.48 lakh crore by curbing leakages and ensuring direct transfers to beneficiaries. Since its inception, ₹44 lakh crore worth of benefits have been transferred via DBT. To put this scale in perspective, counting ₹1 lakh every minute would take over 833 years to reach that total. The DBT model has significantly improved the efficiency and targeting of Government subsidies. India's farmers, too, were long used to hollow promises and minimal budgetary support. Under the UPA, minimum support prices stagnated, insurance schemes were either non-existent or ineffective, and rural distress remained unresolved.

In contrast, the Modi Government quintupled the agriculture budget, distributed nearly 25 crore soil health cards, and directly transferred ₹3.7 lakh crore through PM-Kisan. Over ₹1.75 lakh crore in crop insurance claims have been settled under the PM Fasal Bima Yojana.Women, often relegated to

s the Modi Government marks 11 years in symbolic representation during the UPA years, have emerged as a force in the Modi era.

The Pradhan Mantri Ujjwala Yojana has enabled over 10 crore households to access clean cooking fuel, drastically improving women's health and dig nity. Paid maternity leave was extended to 26 weeks, and women received over 35 crore Mudra loans comprising 68 per cent of total disbursements marking a major departure from the limited economic inclusion offered earlier. The vision of "Lakhpati Didis" aims to turn 3 crore women into income earners, setting a clear goal for empowerment that goes beyond tokenism.

The UPA's approach to education reform and youth development was characterised by bureaucratic inertia and outdated frameworks. By contrast, the Modi Government introduced the National Education Policy (NEP) after 30 years, bringing in multidisciplinary flexibility and investing massively in skill development.

Over 1.6 crore individuals have been trained under the PM Kaushal Vikas Yojana, while more than 1.6 lakh startups many of them youth-led have

emerged, creating over 17 lakh jobs. Infrastructure upgrades under the PM SHRI scheme, the establishment of 7 new IITs and 8 IIMs, and a tripling of AIIMS underline the Government's long-term commitment to building a knowledge economy.

In terms of physical infrastructure, the change is dramatic. Under the UPA, projects moved slowly, and red tape throttled investments. Today, highway construc-

tion proceeds at 34 km per day, metro rail networks have quadrupled, and 86 new airports have been operationalised. The rural road network now spans nearly 4 lakh km, with 99 per cent connectivity achieved. The railway budget has increased ninefold, facilitating the introduction of 400 Vande Bharat trains, transforming connectivity and travel comfort across the country.

More than 136 Vande Bharat trains are currently operational, connecting various cities. On national security and foreign policy, the UPA's tenure was marked by hesitation and passivity. Cross-border terror and infiltration met with little response beyond diplomatic protest.

In contrast, the Modi Government's handling of crises whether surgical strikes and air strikes like Operation Sindoor or rescue missions like Operation Kaveri reflects a clear doctrine of assertive, sovereign decision-making. Defence exports have increased 34 times since 2014. India's defence exports have surged to a record high of ₹23,622 crore in FY 2024-25. Strategic decisions such as the abrogation of Article 370 and the restructuring of the Ordnance

Factory Board highlight a leadership unafraid to act. Economically, India was in a fragile state by 2014 burdened by rising NPAs, stalled investments, and falling investor confidence.

Today, India is the fastest-growing economy in the world. India is the fourth-largest economy in the world, and it leads in innovation and manufacturing. From mobiles to toys, products are now being made in India.

India leads the world in real-time digital transactions (49 per cent of the global total), has reduced NPAs to 2.6 per cent, and FDI inflows have seen a steady rise from USD 36.05 billion in FY 2013-14 to USD 81.04 billion (provisional) in FY 2024-25, marking a 14 per cent increase from USD 71.28 billion in FY 2023-24. The Production-Linked Incentive (PLI) scheme alone has catalysed ₹14 lakh crore in manufacturing output and created 11.5 lakh new jobs. These are not just economic figures, they represent India's transition from fragility to resilience.

The Modi Government has also streamlined the business ecosystem with bold reforms. While the UPA era was defined by complex regulations and outdated laws. India has since climbed 79 ranks in the Ease of Doing Business index and seen a 17-fold increase in patent grants. Over 1.8 lakh companies were registered in 2023-24 alone, supported by simplified labour codes, reduced corporate taxes, and the removal of archaic colonial-era laws.

Culture and heritage, long overlooked, were rejuvenated. Projects like the redevelopment of Kedarnath, the reconstruction of the Ram Mandir, and the repatriation of over 640 stolen artefacts signal a cultural renaissance absent under previous regimes

Initiatives like Swadesh Darshan and HRIDAY have placed India's civilisational legacy back at the heart of public consciousness. Finally, the digital revolution in India has gone from rhetoric to reality. Under the UPA, broadband connectivity was sluggish and internet costs were prohibitive.

Today, with 116 crore mobile subscribers, 6.93 lakh km of fibre optic cable laid, and UPI clocking ₹24 lakh crore in monthly transactions, India has become a global leader in digital infrastructure. Data costs have plummeted by 97 per cent, and 5G now reaches 99.6 per cent of districts, empowering even remote regions with next-generation technology.

In every sphere — governance, economy, security, infrastructure, and inclusion - the Modi Government has not only outperformed its predecessors but has also fundamentally altered the trajectory of India's development. From a nation weighed down by indecision and scandals to one that leads in innovation, delivery, and global confidence, India's transformation from the UPA years to the Modi era is nothing short of historic.

Currently, the Kuruba community, which numbers nearly 60 lakh, holds ST status solely in the Kodagu (Coorg) district. This limitation not only undermines the collective identity of the Kurubas but also perpetuates a legacy of historical injustice that has stymied our community's progress for generations. The removal of geographical restrictions is imperative for recognising our rightful place in the socio-cultural fabric of Karnataka

Historical Context and Cultural Identity

Historically, the Kuruba community has been classified as "Forest and Hill Tribes" since the 1901

Census, indicative of our deep-rooted connection to the natural environment. Our customs, traditions, and livelihoods reflect a rich heritage that transcends mere administrative classifications. Across Karnataka, from the verdant hills of Kodagu to the plains of Mysuru and beyond, the Kurubas share identical cultural practices, language (Kannada), and social rituals that bind us together. Shared religious beliefs, including the worship of deities such as Beerappa and the observance of festivals like Makke Habba, highlight our community's unity in diversity. We boast a unique caste structure and a system of totemic symbolism that further delineates our

identity. The existence of community priests known as Tammadi or Gorava — whose practices differ significantly from those of traditional Brahmin priests - reinforces our distinct cultural lineage.

Socio-economic Challenges

Despite our cultural richness, the Kuruba community continues to face significant socio-economic challenges. Historically dependent on pastoralism, agriculture, and animal husbandry, many Kurubas have struggled due to displacement from their ancestral lands and adverse policies that have marginalised their livelihoods.

For instance, literacy rates among Kurubas have remained abysmally low, with only 1.09 per cent recorded in the 1901 census — a figure that saw only marginal improvement by 1931. Continued socioeconomic marginalisation, exacerbated by living in forests and rural areas, hampers educational opportunities and economic stability for our community.

Recognising the Kuruba tribe as STs throughout Karnataka would open avenues for targeted welfare programs, educational initiatives, and infrastructural development aimed at empowering the community. It would enable us to harness Government support aimed at improving literacy, healthcare, and employment opportunities - essential components for breaking the cycle of poverty.

Legal Justifications for Inclusion

The case for our inclusion as Scheduled Tribes is bolstered by the legal framework surrounding tribal recognition in India. The Supreme Court's rulings have consistently supported the idea of unifying tribal synonyms under the ST list, arguing in favour of shared characteristics that define tribal identity. Moreover, the 1976 ST Amendment allows for proportional adjustments in the context of area expansions, supporting the stance that Kurubas meet the criteria established by the Lokur Committee regarding primitive traits, distinct culture, and geographical isolation. The imposition of

Reorganisation has resulted in the unjust exclusion of Kurubas from the ST list in many regions of Karnataka. This has been a major oversight, given that other tribes such as Naikda, Lambani, and Soliga have been granted state-wide ST recognition without similar constraints. Parliamentary debates as far back as 1976 have underscored the need to eliminate such regional-based restrictions, highlighting a growing consensus on the need for equitable treatment of all tribal communities.

Conclusion: A Collective Path Forward

The plight of the Kuruba tribe is not merely an ethnic issue; it reflects a broader struggle for recognition, dignity, and empowerment in our society. By granting statewide Scheduled Tribe status to the Kuruba community, we will take a decisive step toward rectifying the historical injustices that have marginalised us for too long. This act will not only promote social justice but will also enrich Karnataka's diverse cultural heritage.

As we move forward, we must engage in meaningful dialogue, fostering collaboration between Government authorities and community leaders. Together, we can ensure that the voices of the Kuruba tribe, along with our shared values and aspirations for a brighter future, are heard and respected. It is time to embrace a future where every community, regardless of its history, is given the chance to thrive and contribute to the nation's progress.

Saraswat Bank set to acquire New India Co-op Bank

n a major relief to affected 1.35 lakh account holders and depositors, Saraswat Co-operative Bank Ltd — India's largest urban co-operative Bank initiated the process of merger with New India Co-Op Bank Ltd (NICB) Limited, following an "in-principle" approval given by the Reserve Bank of India (RBI).

Addressing a joint news conference with the Administrator of the RBI restrictions-imposed NICB Ltd, Chairman of Saraswat Bank Gautam E Thakur said that the merger formalities would be completed by August/ September 2025.

Thakur said that the Saraswat Bank which "has a long tradition of taking over financially weak co-operative banks, had so far acquired seven such banks, including Mandvi Cooperative bank and Nashik People's cooperative bank. "The NICB will be the eighth such bank that Saraswat Bank will take over," he said.

Thakur said that after completing the process of "due diligence" lasting for a fortnight, Saraswat Bank had vol-

untarily approached the RBI,saraswat had approached of the NIC depositors". RBI showing readiness to take

over NICB, following which RBI imposed restrictions for the apex bank gave an "in a period of six months on the principle" his bank's proposa. NICB Ltd on February 13,

"The merger process involving the submission of a scheme of amalgamation with NICB to the RBI and subsequent formal approval by the apex bank— will be completed in 45 days to 60 days. During this period both NICB and Saraswat will seek formal sanction from their respective share-holders at general meetings," he said.

"After the RBI approves the scheme of amalgamation submitted by both Saraswat and NIC together, the normal operations of the merged bank will start immediately," Thakur said.

Expressing his happiness over Saraswat Bank's decision to take over the affected bank, **RBI-appointed Administrator** of the RBI Shreekant said: "This is the quickest-ever resolution to a crisis facing a cooperative bank. Two arrested in ₹10 crore online trading fraud

elhi Police have busted a stock trading scam involving a nationwide fraud trail of over ₹10 crore, arresting two men from Gorakhpur, Uttar Pradesh, offi-

cials said on Tuesday. The investigation began after a Delhi resident, Sachin Kumar Tomar, was duped of ₹8.15 lakh through a fake online trading platform.

The case, registered on April 2, 2025, has exposed the elaborate workings of a cyber fraud network that used social media platforms like WhatsApp to lure unsuspecting victims with promises of high returns on stock market investments.

Tomar, a resident of Shivaji Park in Shahdara, came in contact with a woman named Sakshi Yadav on WhatsApp. Over time, she convinced him to invest in a trading platform and added him to a WhatsApp group named "eToro Analytical Team & Time is Money," claiming it was run by her uncle and another man named Rakesh. Trusting her, Tomar deposited ₹8.15 lakh into various bank accounts shared in the group. However, when he attempted to withdraw his supposed profits, the transactions failed and the group became unresponsive. Realizing he had been cheated,

Digital copies of adoption orders valid under new rules: CARA

◄he Central Adoption Resource Authority (CARA) has clarified that adoptive parents do not need hard copies of adoption orders as digitally certified versions sent via e-mail are legally valid and sufficient under the current rules.

In a letter issued to all states, Union Territories, Specialised Adoption Agencies (SAAs) and District Child Protection Units (DCPUs), CARA addressed the confusion surrounding Regulation 13(8) of the Adoption Regulations, 2022, which outlines the procedure for delivering adoption orders to adoptive

families. The clarification comes amid reports that some adoption agencies and protection units were uncertain about the validity of emailed orders, leading to delays and miscommunication in finalising adoption processes.

The regulation mandates that a certified copy of the adoption order — authenticated by the office of the District Magistrate — must be obtained by the SAA through the DĆPU.

This copy must then be sent to the adoptive parents via e-mail within 10 days and uploaded on the desig-nated portal for download.

Clarifying the term "certified copy," CARA said it refers to a digitally authenticated version bearing official attestation, and not a physical original or

hard copy. "Certified digital/emailed copies, as authenticated by the competent authority, shall be considered compliant with the Regulation," the letter said. Čentral Adoption Resource Authority also urged all agencies to coordinate at the district level to resolve procedural hurdles if they arise while securing or forwarding certified copies.

Europe swelters under punishing heat wave

International Criminal Court hit with cyber security attack

International Criminal Court has been targeted by a "sophisticated" cyberattack and is taking measures to limit any damage, the global tribunal announced Monday.

The ICC, which also was hit by a cyberattack in 2023, said the latest incident had been contained but did not elaborate further on the impact or possible motive. "A courtwide impact analysis is being carried out, and steps are already being taken to mitigate any effects of the incident," the court said in a statement.

"All necessary measures have been taken to ensure the business continuity," court spokesman Fadi El Abdallah tions of Russian war crimes in

told The Associated Press.

The incident happened in the same week that The Hague hosted a summit of 32 NATO leaders at a conference centre near the court amid tight security including measures to guard against cyberattacks.

The court declined to sav whether any confidential information had been compromised.

The ICC has a number of high-profile investigations and preliminary inquiries underway in nations around the world and has in the past been the target of espionage. In 2022, a Dutch intelli-

gence agency said it had foiled a plot by a Russian spy using a false Brazilian identity to work as an intern at the court. which is investigating allega-

Government approves ₹1.07 lakh crore ELI Scheme

he central Government on Tuesday approved an Employment Linked Incentive (ELI) scheme with an outlay of ₹1.07 lakh crore to create 3.5 crore jobs over the next two years through social security schemes run by the retirement fund body Employees Provident Fund Organisation (EPFO). The ELI scheme to support

job generation, enhance employability and social security across all sectors, with special focus on the manufacturing sector, was approved by the Union Cabinet in a meeting, chaired by Prime Minister Narendra Modi, Information & Broadcasting Minister Ashwini Vaishnaw said. The scheme aims to incentivise the creation of more than 3.5 crore jobs in the country over two vears, an official statement said.

The Government will incentivise employers, up to Rs 3,000 per month, for two years, for each additional employee with sustained employment for at least six months. For the manufacturing sector, incentives

will be extended to the 3rd and 4th years as well. Establishments, which are registered with EPFO, will be required to hire at least two additional employees (for employers with less than 50 employees) or five additional employees (for employers with 50 or more employees) on a sustained basis for at least six months. The benefit to the

employer (per additional employment per month) will be up to ₹1,000 for employees with a monthly wage of ₹ 10,000, while this will be ₹2,000 for employees with wages of more than ₹10,000 and up to

₹ 20,000. Employees with wages up to ₹10,000 will get a proportional incentive.

The benefit will be ₹3,000 per month to the employers for employees with a wage of more than ₹20,000 (up to a salary of ₹1 lakh per month).

Part B (for employers) is expected to incentivise employers for the creation of additional employment for nearly 2.60 crore persons.

All payments to the first-time employees under part A of the scheme will be made through the DBT (Direct Benefit Transfer) mode using the Aadhar Bridge Payment System (ABPS). Payments to employers under Part B will be made directly into their PAN-linked Accounts. With the ELI scheme, the Government intends to catalyse job creation in all sectors, particularly in the manufacturing sector, besides incentivising youth joining the workforce for the first time.

An important outcome of the scheme will also be the formalisation of the country's workforce by extending social security coverage for crores of young men and women.

India's manufacturing growth hits 14-month high in June

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction. "India's manufacturing PMI reached a 14month high of 58.4 in June. Robust end-demand fuelled expansions in output, new orders, and job creation," said Pranjul Bhandari, Chief India Economist at HSBC.

alling it a "strategic roadmap" for India's elevation into the top five of world sports, the Cabinet on Tuesday approved the Khelo Bharat Niti to create "world-class systems" of coaching and athlete support along with a robust administrative set-up to make the country a strong contender for the 2036 Olympics.

It is a landmark day for India's efforts to encourage sporting talent and become a hub for sports, Prime Minister Narendra Modi said on Tuesday following his government's approval of the 'Khelo Bharat Niti', a national sports policy.

In a post on X, he said this policy is anchored in five pillars: excellence on the global stage, sports for economic development, sports for social development, sports as a people's movement and integration with education through the National Education Policy.

"May Indian sporting talent always flourish," he said.

Previously called the National Sports Policy and introduced for the first time in 1984, the Khelo Bharat Niti 2025 will supersede the 2001 policy. It is a "guiding document" to formulate plans and

India needs to shed conservative selection approach

ndia will need to shed their conservative selection approach and give themselves the best chance to take 20 wickets on what is expected to be another batting surface in the second Test against England, beginning here on Wednesday.

By the team management's own admission, India missed a specialist bowler at Leeds, Kuldeep Yadav to be specific, as England comfortably chased down a record 371 on day five of a game that the visitors should have won.

In the words of assistant coach Ryan ten Doeschate, India are grappling to find a

team combination that doesn't compromise on batting depth and yet has the bowlers to take 20 wickets.

"In terms of managing the strategy there, we're looking at each bowler individually, feeling what we feel they can get wickets-wise. And then it's just trying to balance up and trying to calculate as best you can what the best chance of getting into the Test match.

RR get trade-off offers for six of its players, says IPL sources

Rajasthan Royals might be revisiting their squad composition for the 2026 IPL, with at least six of their players attracting trade-off interest from various franchises.

Although no names have been made public by RR, one of the players, who will be much in demand for a tradeoff is their longtime skipper Sanju Samson. Whether Samson and RR mutually decide to part ways isn't known but Royals do have a second equally potent option in Dhruv Jurel in its ranks.

Two teams, in particular, need a potent wicket-keeper batter. Chennai Super Kings, whose icon player Mahendra Singh Dhoni will be a few months shy off his 45th birthday when next edition of IPL starts, could be looking for options.

The other team could be Kolkata Knight Riders, who are unlikely to repose much

faith in Quinton de Kock ers. Similarly we have and Rahmanullah Gurbaz for an entire duration of the tournament.

While multiple calls to CSK CEO Kashi Viswanathan went unanswered, sources in Rajasthan Royals were also not forthcoming about the talks of trade-off on specific individuals. The trading window for IPL teams opened from June 4, a day after the 2025 final ended and will remain open a

week before the date of the 2026 players' auction. Once the players' auction gets over, the window will open again and will close exactly one month before start of next season. There are multiple kinds of

trade-offs — swapping players at the same price; swapping players where the franchise possessing the player with the higher amount receives the balance; and an all-cash, oneway deal where a franchise sells a player to increase its

purse before the auction. 'There have been multiple approaches by multiple franchises for about six of our play-

approached multiple franchises for multiple options," a source close to the Royals said on conditions of anonymity.

"The bottom line in trades is that every team is open to anything that will strengthen their team, don't think RR will be any different. There are multiple owners who touch base with each other on trades on a regular basis," the source added.

Samson has been integral to the Royals set-up for years, but with Riyan Parag emerging as a potential leadership option, it remains to be seen if the Kerala batter will look for greener pastures.

Rivan captained RR last season when Samson was injured, and many evebrows were raised when he was chosen ahead of Indian cricket's current batting sensation Yashasvi Jaiswal, whose body of work is far superior to that of the Assam youngster.

However, with the Royals having a second base in Guwahati, Riyan remains a strong leadership.
